Welcome & Call To Order: 7:02 pm

- Guest Speaker: Darden Rice, District 4 Councilmember
 - Requests for Paving:
 - Other neighborhoods have paid assessments previously to have the streets paved
 - After payment is completed, city takes over ownership and maintenance
 - City has set aside \$400,000 to cover a portion of the costs for infrastructure and common areas
 - 51% of residents have to sign off on paving
 - Payments can be spread over up to 30 years
 - City Council will vote on approving 0.00% interest on assessment payments
- Guest Speaker: Brejesh Prayman, Dir Engineering & Capital Improvements
 - Requests for Paving:
 - 12th St N from 36th Ave N to 38th Ave N
 - 36th Terrace N from 12th St N to 13th St N
 - 37th Ave N from 12th St N to 14th St N
 - Submitted as 8 separate Special Assessment requests (by block), each individual request requires 51% of the affected residents to approve
 - Concerns about assessments to residents
 - Original street paving through neighborhoods was paid by city
 - Specific streets "opted out" of paving with the understanding that any future change would require resident assessments
 - City Code has been updated with the process improvements implemented as a result of Mag Heights request
 - City is looking into alternative types of payment to try to lower costs

- Current amount assessed is the maximum each resident will be responsible for
- If approved, the design process will identify the best option for each segment
- Current vote only begins engineering study to provide more accurate design and estimates
- Residents will have additional opportunity to approve or reject paving
- City will bring in an arborist to see if any trees will be affected
 - The intent is not to remove any trees but, if necessary, they will be replaced
- Minimum street width, per federal guidelines, is 19 feet. Streets will not be widened beyond this standard
 - Concern about loss of private property
 - Some streets were "paved" approx. 16 years ago
