  - 28 Years with SPPD Communications
  - O What to expect when you call 911:
    - In Pinellas County, all calls are routed through regional center in Largo where Fire, Medical, and EMS are dispatched
    - All Law Enforcement calls transferred to SPPD Center
    - Non-emergency line connects to Dispatch directly, but calls will be prioritized behind 911 calls
    - Locations received automatically for landlines, cell phones are not exact – will confirm address
    - Call is first answered by Call-Taker, information is sent to dispatcher then officer
  - Community Assistance and Life Liaison Program (CALL)
    - Licensed mental health professionals respond to calls related to mental health crises or social services
    - Renewed contract in September for additional 2 years
    - Officers can refer cases to CALL for follow-up
  - SPPD moving towards Officers focusing on crime, increasing referrals to other services
